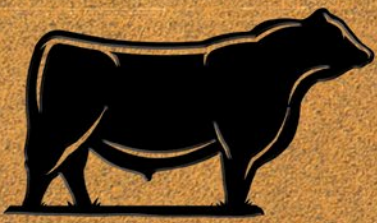

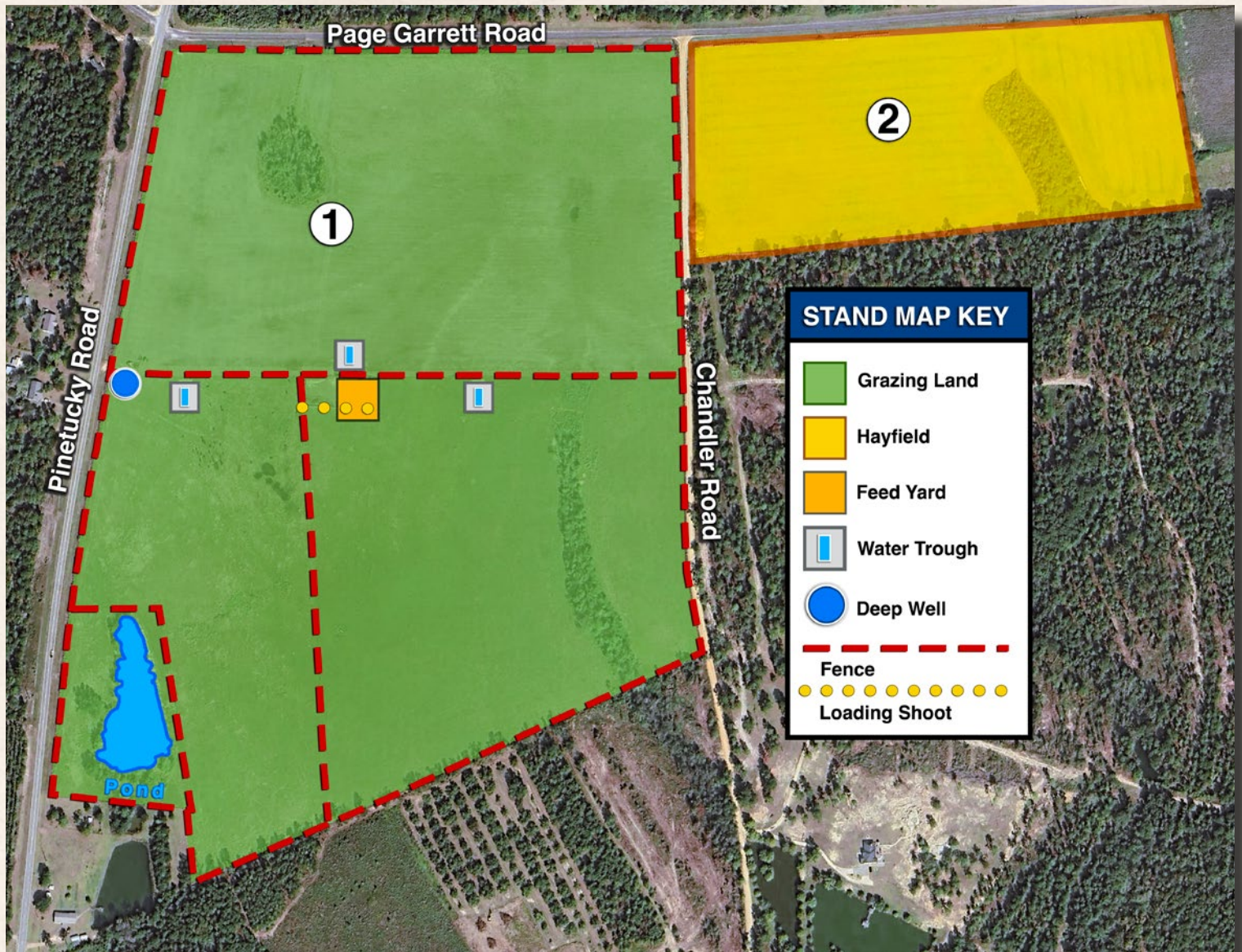

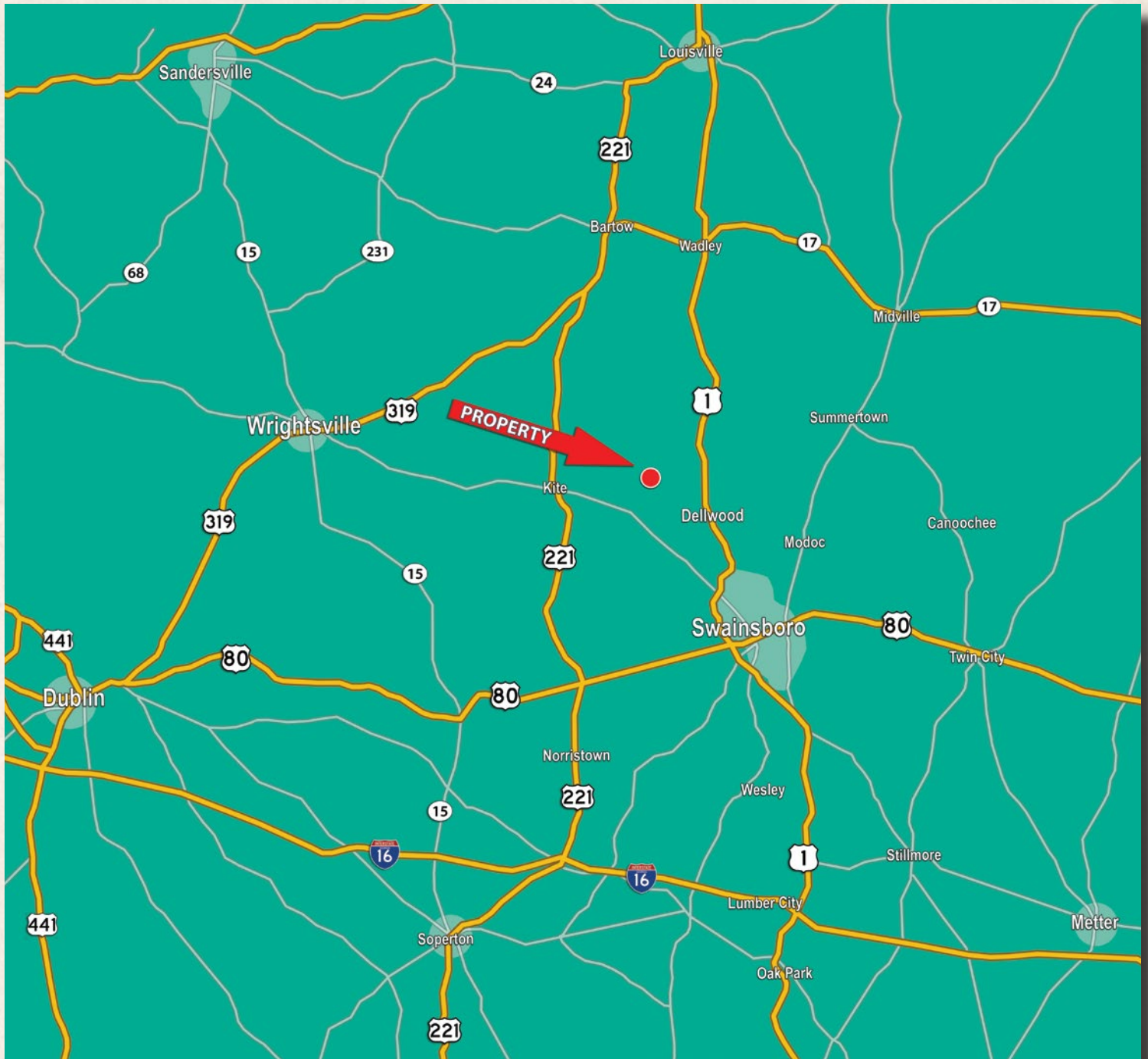

LOCATION MAP





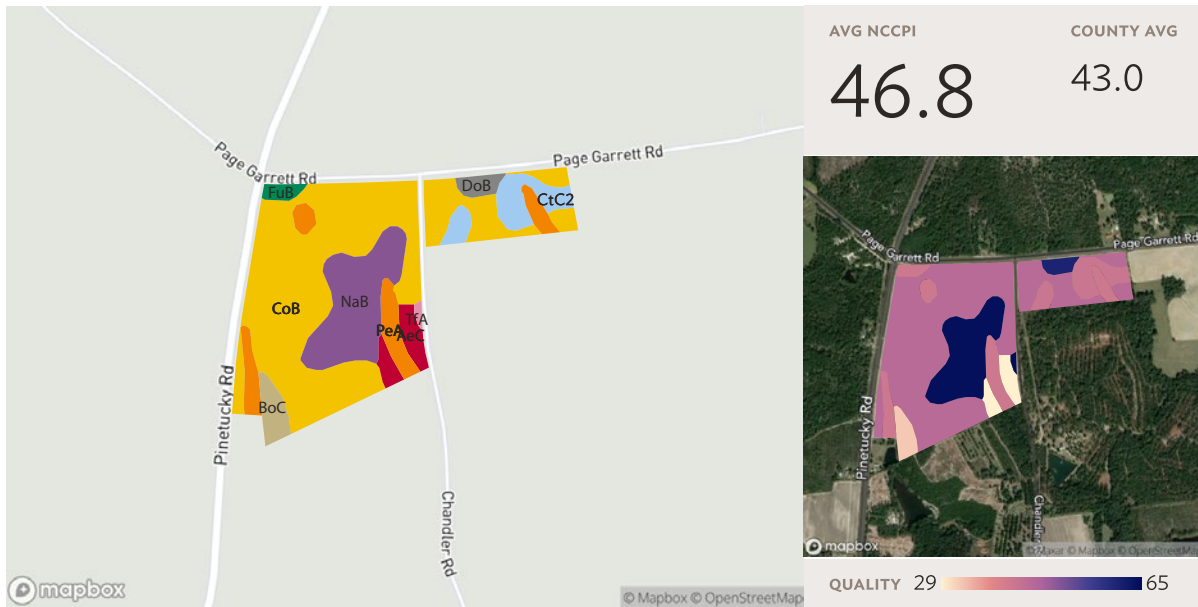

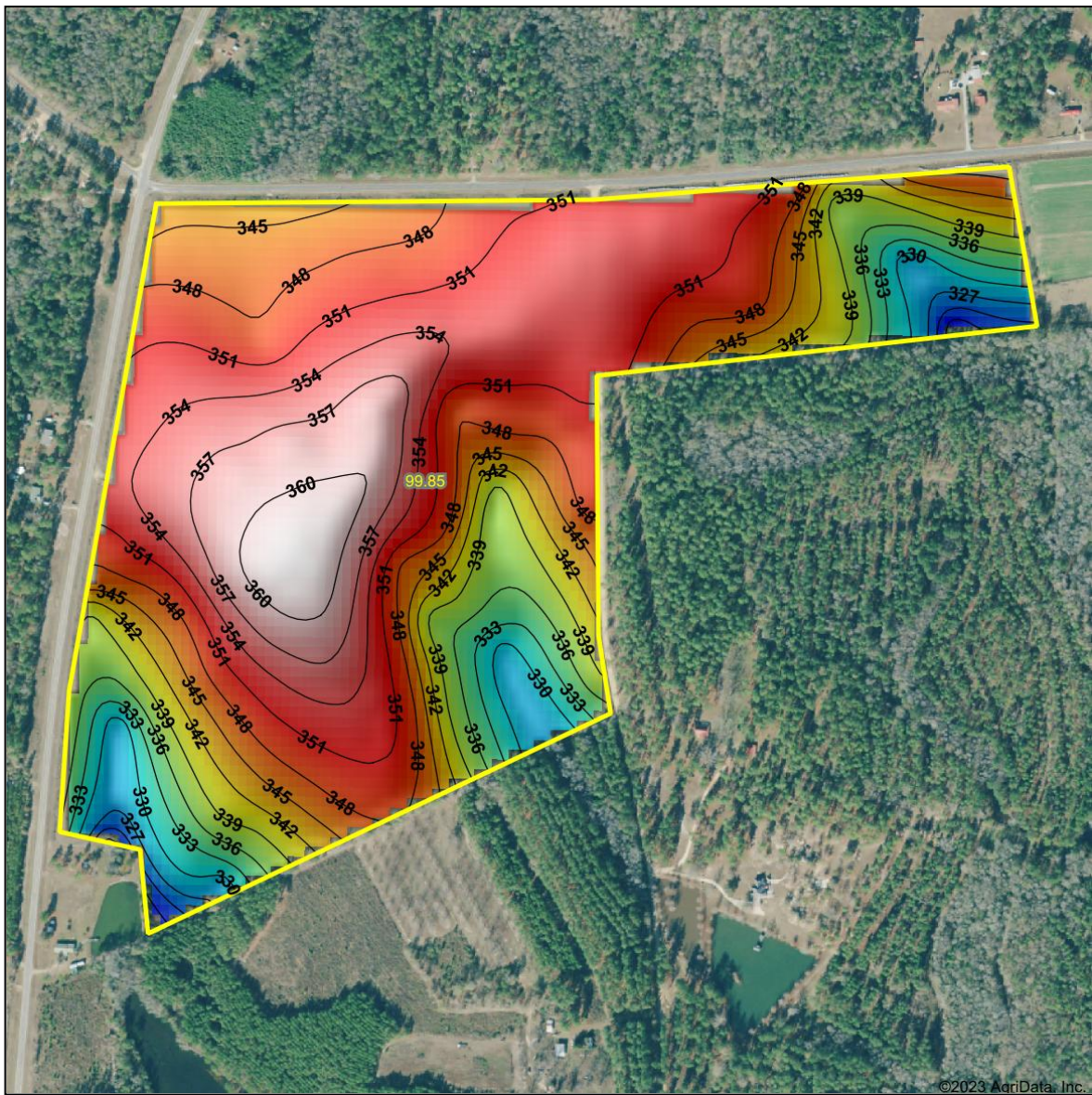
